## MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

This MEMORANDUM OF UNDERSTANDING (hereinafter referred to as "MOU") is made at Dhaka, Bangladesh on this the **August 16, 2020** of the Christian era.

Faiz Ullah or Nominated Authorized Representative (hereinafter referred to as the "Ibn Sina Trust", (which expression shall, unless excluded by or repugnant to the context or meaning thereof, mean and include its successors-in-interest, legal representatives, administrators, executors, and assignees) of the **FIRST PARTY**.

And

**BANGLADESH CHEMICAL INDUSTRIES CORPORATION (BCIC)**, a govt organization, having its head office at BCIC Bhaban, 30-31, Dilkusha C.A, Dhaka 100, Bangladesh Tel # 02-9559281-82, bcic.gov.bd/ represented by its **Secretary** or Nominated Authorized Representative (here in after referred to as the **Bangladesh Chemical Industries Corporation (BCIC)** (which expression shall, unless excluded by or repugnant to the context or meaning thereof, mean and include its successors-in-interest, legal representatives, administrators, executors, and assignees) of the **SECOND PARTY**.

- Whereas **IBN SINA TRUST** (1<sup>st</sup> party) is the pioneer organization in health care sector in Bangladesh and committed to render world-class services with reasonable cost.
- And Whereas **BANGLADESH CHEMICAL INDUSTRIES CORPORATION (BCIC)** ("2<sup>nd</sup> party") is desirous to take medical services for their **Employees and their legal dependents** from all unit of **IBN SINA TRUST** under the following terms & conditions:

1. The **IBN SINA TRUST** agrees to provide the following discounts on medical services in the area of IPD & OPD to the Employees and their legal dependents of **BANGLADESH CHEMICAL INDUSTRIES CORPORATION (BCIC) & all of its sister concerns (Factories & Projects);**
  - a. **35%** discount on all kinds of Pathological Tests
  - b. **30%** discount on PCR Tests
  - c. **30%** discount on all kinds of Radiological and Imaging Tests.
  - d. **10%** discount on dental services,
  - e. **10%** discount on hospital bed rent (from Ibn Sina Medical College Hospital, Kallyanpur, Ibn Sina Hospital, Sylhet & Jashore).

**\*\* COVID or COVID suspected patient will get preference for COVID-19 test and hospital admission if necessary. (only at Ibn Sina Medical College Hospital, Kallyanpur, Dhaka).**
2. The discount provided by the **IBN SINA TRUST** shall exclusively apply to the Employees of **BANGLADESH CHEMICAL INDUSTRIES CORPORATION (BCIC)** and their legal dependents. Legal dependents are parents, Spouse and children. Any other facilities, if includes/increases in future by the **IBN SINA TRUST** authority, which will be applicable under this agreement and will be informed to **BANGLADESH CHEMICAL INDUSTRIES CORPORATION (BCIC)**.
3. **COVID-19 Test & Admission:**
  - 3.1. Employees of **BANGLADESH CHEMICAL INDUSTRIES CORPORATION (BCIC)** with their dependents (spouse, children & parents) will get preference for COVID-19 test and hospital admission if necessary.
  - 3.2. Covid-19 patient will get the services from Ibn Sina Medical College Hospital, Kallyanpur, (If COVID bed / ICU available or vacant).
  - 3.3. If need to sample collection for Covid-19 test from 2<sup>nd</sup> party's office premises, the test rate with collection fee will be charged **BDT-4000.00 (Four Thousand Taka) per patient (for minimum 20 employees in one setting)** instead of regular price BDT- 4500.00/-
  - 3.4. If any employee or their dependents are referred to Ibn Sina Medical College Hospital, Kallyanpur for testing COVID-19, will be charged **BDT-3800.00 (Three Thousand Eight Hundred Taka) per patient. (Test rate; BDT-3500/- & Procedure Charge; BDT-300/-)**
  - 3.5. If any Employees and their legal dependents need for testing Covid-19, will get the priority & prompt services. In that case, an authorized person can communicate with Ibn Sina's corporate contact person for appointment.
  - 3.6. The report will be delivered within 24 hours after giving sample/specimen.

**4. Identification:**

- 4.1. Employees show Employee ID card or any written documents with authorized signature / **IBN SINA TRUST** provided corporate health card.
- 4.2. Dependents will show the photocopy of respective employee's ID card or **IBN SINA TRUST** provided corporate health card.
- 4.3. **IBN SINA TRUST** will issue Corporate Health Card at a cost of TK 100.00 (One hundred only) per card (If 2<sup>nd</sup> Party is interested).
5. All payments of the medical services shall be made in cash/debit or credit card by the Employees of **BANGLADESH CHEMICAL INDUSTRIES CORPORATION (BCIC)** and the **IBN SINA TRUST** shall provide the respective invoices for such medical services provided to the Employees of 2<sup>nd</sup> parties.
6. **IBN SINA TRUST** and (including their officers, employees and independent contractors) shall treat all information received from each other as confidential and undertakes not to disclose any confidential information to any third party. This clause shall be enforceable even after the termination of this agreement.
7. This MOU shall be governed in accordance with the relevant laws of the People's Republic of Bangladesh for the time being in force. If any difference arises as to resolution of any matter under this agreement, such difference shall be settled through mutual discussion between both the parties. However, the parties do consent and submit to the exclusive jurisdiction and venue of the Bangladesh courts for any litigation with regard to execution, performance or breach in any manner arising out of this contract if not resolved mutually.
8. This MOU shall take on effect from **16<sup>th</sup> August 2020** for a period of 2 (Two) years. It shall be automatically renewed at the end of its validity period unless either party desires to terminate this MOU by giving 30 (Thirty) day's notice in writing prior to expiry of the MOU.
